#### 1. <u>INTRODUCTION:</u>

Vadodara Municipal Corporation with a theme of water conservation and making use of waste water, decided to take up the pledge to transform lakes of the city in to lively water bodies with restored aquatic ecology and saving the environment of the city.

As untreated sewerage from the neighboring area enters the lake through the connected drainage systems, daily deposition of organic and inorganic material gives rise to eutrophication and decomposition of the same by natural way is resulting into sludge accumulation. The project is purely focused upon the reinstating the natural ecosystem and making the water quality adequate to support life, with a clear and straightforward objective to remove all harmful aquatic weeds, increase the Dissolved Oxygen (DO) level, reduce Biochemical Oxygen Demand (BOD) and Chemical Oxygen Demand (COD), increase the depth of the water body, significant reduction of nutrient elements (like Nitrogen and Phosphorus access of which is harmful for aqua life to balance the ecology, and plantation of Phyllostachys pubescens or other equivalent for natural air purification and CO<sub>2</sub> absorption.

#### 3. OBJECTIVES & SCOPE OF WORK

Water in the lake/ pond is contaminated due to various reasons, the water is deficient in dissolved oxygen and rich in nutrients and organic matter and Suspended solids. VMC invites proven technology for in-situ treatment of lake/pond water through Bioremediation and Aeration system or equivalent technology.

For the eco-friendly bioremediation of Gotri ponds/lake in Vadodara and creating a good ambiance for the visitors, microbial cultures will be used to prevent the chemical exposure, reduction of organic waste in the water and promoting a better environment.

- 1. The bidder may express their willingness and interest, singly or jointly, in doing this work in writing along with their Company profile, Capability, Experience, Experience in similar work (Similar work means in-situ treatment of lake/pond water) and annual turnover etc to VMC.
- 2. The bidder is free to offer / suggest proven technique with design, relevant calculations, implementation sequences/strategy to achieve goals (as per standard requirements) etc.
- 3. Technology offered should be such that part or whole lake is not dried out or emptied during the work. Also no harmful chemicals should be used for the above said project.
- 4. Bidders will be short listed based on information submitted as above (1) and /or if required will be invited for the presentation with information mentioned at (1).

#### 4. GENERAL CONDITIONS OF CONTRACT:

- Manufacturer should have an in-house DSIR recognized R&D facility.
- Manufacturer should have a SSI registration certification
- Manufacturer should have company registration certification with the registration number
- Manufacturing of the product should be done in a GMP certified facility
- Products should be Non Toxic, certificate from NABL approval
- Manufacturer should have recognized quality certificates such as ISO certification
- Manufacturer should have reasonable office establishment in India with adequate qualified personnel to perform technical, administrative and commercial function.

#### 5. ELIGIBILITY CRITERIA

### 7. BID EVALUATION

Bid Process Criteria (EOI Stage) for Selection of Bidders FOR LAKE PURIFICATION & REMEDIATION WITH BIOREMEDIATION OR EQUIVALENT TECHNOLOGY IN GOTRI LAKE, VADODARA

#### **Stage-I: Invitation of EOI**

Expression of Interest (EOI) is invited in prescribed format for understanding the response from the investors. Interested agencies shall submit their offer to VMC on or before 16:00 hours on dated 20/08/2019 by RPAD/Speed post only.

#### **Stage-II: Short listing of EOIs**

#### Criteria:

VMC shall shortlist the agencies on the basis of qualifying document submitted. Short listed agencies shall be asked to make presentation for their proposals. VMC authority may ask any agency to incorporate their suggestions in their presentation or a common design may be prepared incorporating important features from the design of all the bidders.

#### **Stage-III: Call for Financial Bid**

On Approval of final Planning/Design, VMC shall ask to the qualified bidders for the financial bid to submit separately.
